WHAT TO DO & WHAT NOT TO DO WHEN YOU ARE SERVED with a PROTECTION FROM ABUSE ORDER (PFA)

What is a Protection From Abuse Order(PFA)?

A protection from abuse order is a civil court order that provides protection for an individual who has been abused, harassed, threatened, or stalked. It is a court order signed by a judge ordering you to have no contact with the alleged victim, and may include children, or you will face serious legal consequences.

When does the PFA become effective?

The order you have is a temporary order. A hearing is scheduled to occur within ten days to consider a permanent order. At the hearing you will have an opportunity to state your case. A permanent order may restrict you for a period of up to three years.

What if we have children together and the PFA states I cannot have contact with them?

If you share children with the petitioner of the PFA, and your children have been listed as a protected party on the PFA, you are NOT permitted to contact them unless specified within the PFA, or until a final decision has been made at the final PFA hearing.

If you violate the PFA, you WILL be arrested.

When a PFA is served against you:



What NOT to do:

- **✓ Do Not** go home if evicted
- ✓ **Do Not** call, text, write, email or use social media with protected person
- ✓ **Do Not** go near the protected person's home, work, or school
- ✓ **Do Not** attempt to contact the protected person through children or a third party



What can I do?

- ✓ Read your PFA carefully and contact an attorney if you have any questions
 - ✓ Attend the hearing that is scheduled
 - ✓ Contact a Domestic Abuse
 Intervention Program



HOW DO I GET MY PERSONAL THINGS FROM MY HOME?

- ✓ Call an attorney
- ✓ Wait until after the PFA hearing, when arrangements to get your belongings can be made with the court's approval

Where do I go if I am evicted?

- ✓ Call family or friends for a place to stay
- ✓ Go to a motel
- √ Go to a shelter (listed in pamphlet)

What happens to my firearms?



If the order indicates a relinquishing of personal weapons, DO NOT attempt to get your weapons. The disposition on any seizure will be determined at your hearing.
